I will not purchase gambling equipment from any person not licensed as a manufacturer under Minnesota Rules 7864.0210, except for gambling equipment returned from a licensed, exempt, or excluded organization.</li> <li>18. I will not sell gambling equipment to any person for use in Minnesota other than a licensed, exempt, or excluded organization, or the governing body of an Indian Tribe.</li> <li>19. I will not sell or otherwise provide a pull-tab or tipboard deal with the symbol required by Minnesota Statute 349.163, Subd. 5(d), visible on the flare to any person other than in Minnesota to a licensed or exempt organization.</li> <li>20. I will not enter into any agreement with any other distributor that restricts either of them in the sale of gambling equipment.</li> <li>26. I will not enter into any agreement with any other distributor to establish the price at which any gambling equipment may be sold.</li> </ol> <p>In addition, I understand, agree, and hereby irrevocably consent that suits and actions relating to the subject matter of the distributor salesperson license application, or acts or omissions arising from such application, may be commenced against me in any court of competent jurisdiction in Minnesota by service on the Minnesota Secretary of State of any summons, process, or pleading authorized by the laws of Minnesota.</p> <p><b>By signature of this document</b>, the undersigned authorizes the Department of Public Safety to conduct a background investigation pursuant to Minnesota Rule 7863.0210, Subp. 8A.</p> <p><b>Changes</b> in application information will be submitted within 10 days of the change. Failure to provide required information or providing false or misleading information may result in the denial or revocation of the license.</p>

<p>A salesperson must obtain a license and picture ID card and may not be employed by more than one distributor at a time.</p> <p><b>Changing distributor employment:</b> If you change employment to another distributor after you have received your distributor salesperson license, submit to the Gambling Control Board:</p> <ol style="list-style-type: none"> <li>1. a letter stating the date you terminated employment with the previous distributor, and</li> <li>2. a letter from the distributor with whom you will be employed. Include the effective date of your employment.</li> </ol> <p>There is no fee when changing employment during the term of your (one year) salesperson's license.</p>

**Data privacy notice:** The information requested on this form (and any attachments) will be used by the Gambling Control Board (Board) to determine your qualifications to be involved in lawful gambling activities in Minnesota, and to assist the Board in conducting a background investigation of you. You have the right to refuse to supply the information requested; however, if you refuse to supply this information, the Board may not be able to determine your qualifications and, as a consequence, may refuse to issue you a license. If you supply the information requested, the Board will be able to process your application. You are required to provide your Social Security

number that will be used to determine your compliance with the tax laws of Minnesota. Authorization for requiring your Social Security number is found at 42 U.S.C. 405(c)(i).

Your name and address will be public information when received by the Board. All other information provided will be private data about you until the Board issues your license. When the Board issues your license, all information provided will become public except for your Social Security number, which remains private. If the Board does not issue you a license, all information provided remains private, with the exception of your name and address, which

will remain public. Private data about you are available to: Board members, Board staff whose work requires access to the information; Minnesota's Department of Public Safety; Attorney General; Commissioners of Administration, Minnesota Management & Budget, Revenue; Legislative Auditor; national and international gambling regulatory agencies; anyone pursuant to court order; other individuals and agencies specifically authorized by state or federal law to have access to the information; individuals and agencies for which law or legal order authorizes a new use or sharing of information after this Notice was given; and anyone with your written consent.
